Email alerts are automatically sent to suppliers before and after their insurance policies expire, giving them the opportunity to make timely updates and remain compliant.



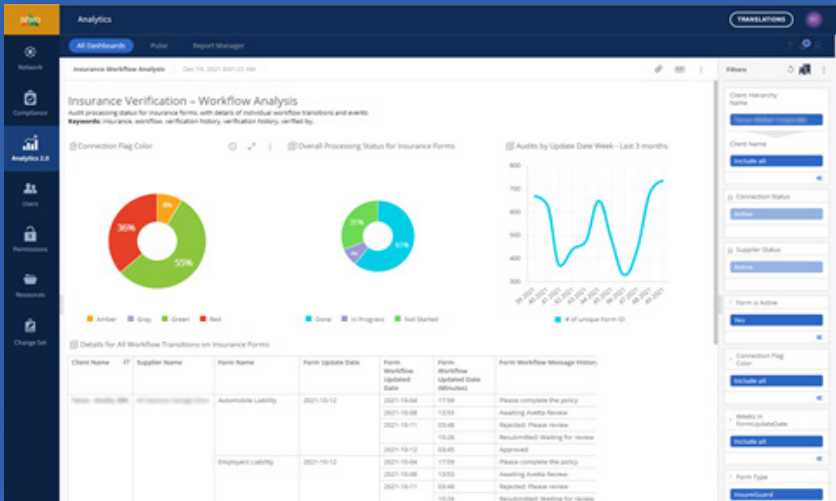
## Real-time monitoring

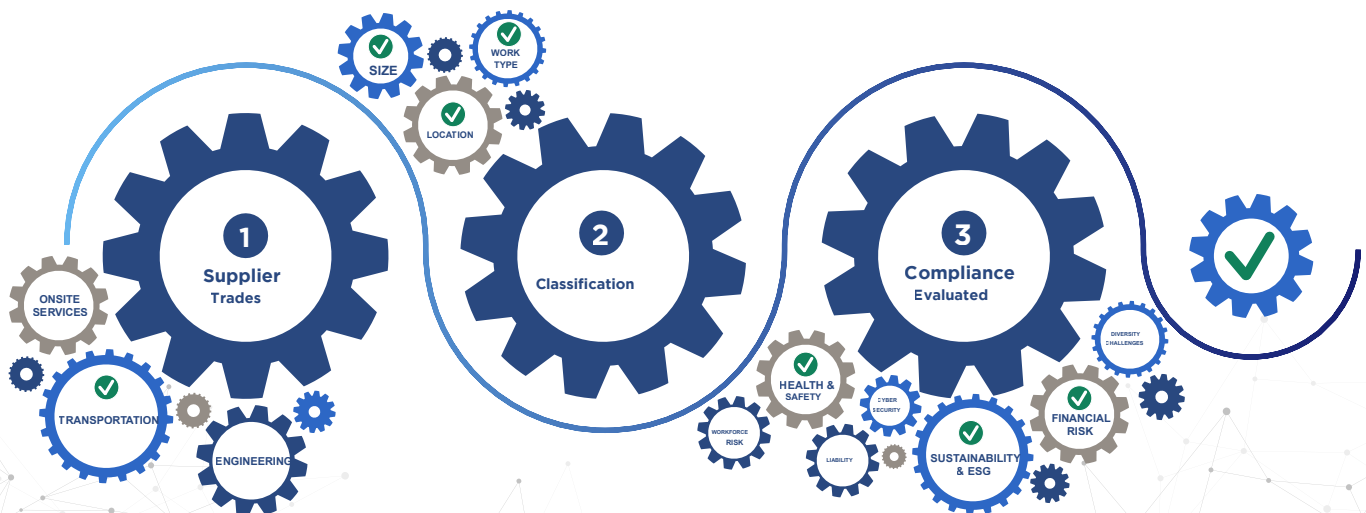
